GAS 15/01/16 HERITAGE FUND ALLOCATIONS 2014-15 (CS-14-1402)

Mr Rob Cross, Biodiversity Advisor, spoke to report CS-14-1402, which summarises applications for grants from the Heritage Fund in 2013/14 and makes recommendations on funding allocations. Mr Cross gave a presentation comprising photographs of the sites of the 10 applications and advised what each application was for. Questions were raised on the following applications:

(a) Waiorongomai Road, Ōtaki

Cr Holborow asked Mr Cross how much planting had been done. Mr Cross replied they have used a technique where large established flax bushes are spilt up and divided, which is a cheap and effective restoration technique around lakes like this. They have probably planted around 1,000 plants so far. With the funding from KCDC and from Greater Wellington Regional Council (GWRC), they have also applied to Nga Whenua Rahui for funding, and with this money they hope to ramp up the planting around the lake.

(b) 516 SH 1, Waikanae

Cr Bell asked about the work done to date. Mr Cross explained that successful weed control was an iterative process.

(c) 150 Taylors Road, Ōtaki

It was noted that the balance of funding was being provided by GWRC.

Mr Cross said that if all the applications are funded, the budget will be fully expended.

Both Crs Bell and Holborow thanked Mr Cross for his comprehensive report.

There was discussion on Mr Cross' input to the Proposed District Plan (PDP) process regarding biodiversity issues, noting that while the PDP contained innovative and potentially effective ways of protecting native vegetation and the habitat of threatened species, some aspects of the PDP had not been well received by rural landowners. Mr Cross would continue to be involved in discussions with the PDP team led by Mr Lew. Mr Cross confirmed he was working closely with GWRC and landowners.
