(a) Resource consent application renewal

The Committee inquired of the current status of the resource consent application. Mr Currie advised that the application had previously been on hold as further information was required - this information has now been received and the application is being processed and a decision is to be made on whether the application is to be notified.

He explained that if the application is on a limited notification, other land owners, who are considered an “affected person” will be notified and they would have the opportunity to lodge a submission.

Mr Currie will ensure the committee is advised of the progress of the consent and any related decisions.

The Committee discussed that given there is a new consent application in process it is timely to consider, that The members could possibly better represent their more general interest in Kapiti Island through a different forum.

Mr Currie confirmed that if this Committee were to wind up that the intention is that Council would continue with the monitoring that is currently undertaken.

The Paraparaumu Raumati Community Board has had some early discussions about exploring alternative forums relating to Kapiti Island.
