PRESENTATION: WELLINGTON REGIONAL GROWTH FRAMEWORK

Janice McDougall introduced Kim Kelly from Greater Wellington Regional Council. Ms Kelly spoke to a presentation and answered members' questions.

The draft objectives of the projects were outlined:

- 1. Improve housing affordability
- 2. Enable growth that protects and enhances the quality of the natural environments and accounts for a transition to a low/no carbon future
- 3. Improve access to and between housing, employment, education and services utilising all multi-modal transport choices
- 4. Encourage sustainable, resilience and affordable settlement patterns/urban form that make efficient use of existing infrastructure and resources
- 5. Build climate change resilience and avoid increasing the impacts and risk of natural hazards
- 6. Create employment opportunities

<u>Kaianga Ora Bill</u>. The Council had made an initial draft submission to the Kaianga Ora Bill, which would be presented to Strategy & Policy Committee 1 Septmber 2019 for ratification.

There is a section of the bill that outlines the responsibilities Kaianga Ora will have to work with iwi.

A second tranch of legislation later this year would cover the enabling powers that the organisation would have.

The Bill allows central government to focus on urban development joining up a number of government agencies who work in this space. It will also enable the development of urban development authorities at a very local level.

Mrs McDougall indicated staff would seek iwi input into the submission on the legislation due for consultation later in the year.

<u>The Maramataka</u>. Te Atiawa had confirmed they are comfortable with the arrangements. Invitiations will be issued.

<u>Capacity contracts</u>. Pulling the list together of work planned for the yer where council staff would like to work with iwi.

<u>Waitangi Day</u>. It was agreed that the confirmation of who would host the next Waitangi day would be on the agenda for the September meeting of Te Whakaminenga o Kāpiti.
