UPDATE FROM GREATER WELLINGTON REGIONAL COUNCIL (GWRC)

The Chair invited Cr Nigel Wilson, GWRC to provide an update to the Board, this included:

- The next bus shelter to be installed will be near Countdown Ōtaki; they are working through landowner issues and a design will come back to the Community Board. Cr Wilson will provide the installation date.
- GWRC has been having dialogue around the Bus route that has been suggested by members of the community to improve services. GWRC asked the Board for additional information which will feed into a system they have to analyse the data.
- Cr Wilson suggested that it might be timely for the Board to meet with Cr Paul Swain from GWRC and discuss the ongoing public transport issues in Ōtaki.
- GWRC are putting in a consent around River Management which will help with some of the flooding issues in the area;
- Councillor Wilson has received queries around flooding from the community around who takes responsibility. There needs to be some clarity around this and who takes ownership of what.

- They would like an update on the Te Horo bus stop and also what is happening with the relocation to Ōtaki for the redundant Peka Peka bus stop;
- There are still a number of connection issues with the buses between Ōtaki and Waikanae and the Board continues to advocate for increased services and have also asked Cr Wilson to advocate for increased services.
- The transport issues need to be addressed in Ōtaki and there needs to be dates and timeframes put in place;
- The Board asked again what would be the targeted rate if the Community wanted additional bus shelters. This question was asked last year and the Board is still awaiting a response.

- He attended the welcoming of the 72nd Ōtaki scholar;
- The i-Site maps have been completed and have gone up around Ōtaki and a manual has been completed with information relating to Ōtaki;
- He acknowledged all the work that had been put in on the campaign to save the Capital Connection by Cr Penny Gaylor and the work of the Save the Capital Connection Group.
- The Ultra-Fast Broadband proposal has been submitted to Government;
- Have met with GWRC and Kapiti Coast District Council and visited the areas that were affected by the recent flooding;
- NZTA will provide a PP2O update at the next Ōtaki Community Board meeting;
- SH1 Sign – designs have been confirmed and they will go to print shortly.

Rob Kofoed made the following comments

- Attended the Ōtaki Foodbank meeting on 10 June; there have been a total of 1,734 parcels delivered this year;
- Attended the Friends of the Ōtaki River planting on 28 June;
- Attended the Ōtaki Civil Defence Meeting on 13 July. At the meeting there was a review done on the recent flooding in June.

Colin Pearce

- The WW1 Display was well received with over 3,140 visitors attending. The next display will focus on Kāpiti island and its connection to Ōtaki;
- He has spoken with Council staff about Ōtaki Beach and discussed traffic calming, pedestrian crossings, parking and also about how the toilets can be improved at the Pavilion at Ōtaki Beach;
- Footpath in Waerenga Road has just been sealed, will it be pulled up if Ōtaki gets UFB;
- North of Castle Hill Farm on Rahui Road there is a drain that is filled with bullrushes that needs to be cleared; this was highlighted with the recent flooding.
