- 1. Chris Turver took the opportunity to thank the Board for its support of the Waikanae Boating Club in obtaining a renewal of its lease for 30 years.
 - On behalf of the Waikanae Estuary Whitebaiters Network, Mr Turver spoke about the steady ecological and environmental degeneration of the Waikanae estuary area. The purpose of Mr Turver's submission was to gain Board support in restoring the health of the estuary (paper circulated).
- 2. Nita Ropata-Riki from Problem Gambling Federation spoke about the group's activities regarding the Sinking Lid Policy which reduces the number of gaming machines and venues in the community (paper distributed) and responded to questions from the Board.

- 3. Tim Abbott said he was dismayed by the poor attendance at the Board's meeting. Mr Abbott spoke about the current development and parking issues facing Waikanae.
- 4. Cr James Cootes spoke as a business owner affected by the proposed changes to parking in the Ngaio Road service-lane carpark. If the Waikanae Town Centre Parking Review recommendations were adopted, this would affect many Mahara Place businesses, rather than the commuters who were the real problem. In speaking with local business owners, it was clear they did not support Council's proposal (circulated photos).

The Board shared the concerns Cr Cootes had raised.

UPDATE: KĀPITI COAST DISTRICTWIDE SPEED LIMIT REVIEW: STAGE 2

Traffic Engineer, Diana Munster provided the Board with an update on Stage 2 of the Speed Limit Review (circulated paper). The focus of this stage was to complete the rural roads and three village areas review.

In January 2019, updated graphics, overview and individual maps will be available on Council's website and these will show the proposed speed limits with explanations.

The speed limit through Waikanae was not part of the review but would be looked at by NZTA as part of the revocation process.

WAIKANAE TOWN CENTRE PARKING REVIEW (IS-18-655)

The Board considered report IS-18-655 and Traffic Engineer, Gary Adams spoke to the report.

Council had undertaken surveys and conducted counts to determine the parking issues for the township area.

In response to issues raised by Cr Cootes, Mr Mallon said recommendation for a 4-hour limit was a similar strategy that was applied through the Paraparaumu Town Centre area where there were issues with commuter parking.

The Board asked why commuter vehicles exceeding the 8-hour time limit were not being ticketed and Mr Adams said it was a resourcing issue, where one parking enforcement officer was only available for 15 hours per week. The Board requested that an education approach with signage be introduced and if this failed to improve the long-term parking problems, then enforcement of the 8-hour time limit was implemented.

MOVED (M Scott/Begovich)

That the Waikanae Community Board rejects the following parking restrictions:

- 24 Change two spaces at the southern end of the Ngaio Road service land carpark to a loading zone for the use of the businesses to service their premises.
- 25 Reduce the time limit in the Ngaio Road service lane carpark to 4 hours.

That the Waikanae Community Board approves the following parking restriction for ratification by Council:

26 Re-arrange parking on Elizabeth Street, moving one of the P10 spaces east of the vehicle crossing to 12 Elizabeth Street and change the P10 space at the western end outside Relish Café to a P60 restriction.

UPDATE: WAIKANAE MINOR SAFETY PROJECT

Traffic Engineer, Gary Adams provided the Board with an update about the upcoming minor improvement works at the Te Moana Road/Rauparaha Street intersection.

The crash history, one of which was serious and the numerous near misses had highlighted for Council the need to address safety issues at this intersection. Additionally, a change in travel patterns based on the Expressway interchange had been a contributing factor.

The Board strongly urged Council to engage with local community groups ie. Waikanae Beach Residents Society and other local residents before any changes are implemented, as these are more than minor and will affect the entrance to Waikanae Beach. The Board looked forward to receiving the community engagement feedback in the New Year.

The Board thanked Traffic Engineers, Mr Adams and Ms Munster for their respective presentations.
