I. Walkable catchments extents

The level of commercial activities in the Local centres (eg Mazengarb & Waikanae beach) is too low to justify a 4-storey buildings within a General Residential Zone (GRZ) 200m walkable catchment. This stems from Policy 3(d). Therefore the walkable catchment should be amended as follows for General Residential Zone:

a) Within an 800m walkable catchment of the edge of the Metropolitan Centre Zone - applicable to GRZ in Paraparaumu

This must be reduced from 800m walkable catchment to 400m

b) Within an 800m walkable catchment of a rapid transit stop - applicable from Waikanae station, Paraparaumu station, Paekākāriki station

Keep this walkable catchment as it is 800m

c) Within a 400m walkable catchment of the Town Centre Zone - applicable to GRZ in Ōtaki Main Street, Ōtaki Railway, Paraparaumu Beach, Raumati Beach This must be reduced from 400m walkable catchment to 200m

d) Within a 200m walkable catchment of the Local Centre Zone - applicable to GRZ in Walkanae Beach, Kena Kena, Mazengarb Road, Meadows, Raumati South

This must be reduced from 200m walkable catchment to 100m

II. UFD-Px Urban Built Form

Given that the Kapiti Coast is of a small geographic size and has beach village character, higher density up to 12-storeys is not justifiable and will mean that the Kapiti community will lose its special character and charm. Also, sites subject to a qualifying matter should not benefit from the intensification rules. Therefore this policy should be amended as follows:

Provide for heights and densities of urban built form that enable more people to live in, and more

businesses and community services to be located in, the District's urban environments, by: 1. enabling the greatest building heights and densities in the Metropolitan Centre Zone, including buildings up to 127-storeys;

2. enabling greater building heights and densities within a walkable catchment of the Metropolitan Centre Zone and the train stations at Paekākāriki, Paraparaumu and Waikanae, including buildings up to 6-storeys;

3. enabling greater building heights and densities in the Town Centre Zone, including buildings up to-65-storeys;

4. enabling increased building heights and densities in the Local Centre Zone, including buildings up to 4-storeys;

5. enabling increased building heights and densities adjacent to the Town Centre Zone and Local Centre Zone, including buildings up to 4-storeys; and

6. enabling a variety of building heights and densities in the General Residential Zone, including buildings up to 3-storeys;

while avoiding inappropriate buildings, activities, heights and densities within <u>sites subject to</u> qualifying matters areas.

III. DO-Ox3 Residential Intensification Precincts & Precincts labelling

the number of precincts should be increase to reflect the intensification allowed in the revised walkable catchment areas and revised heights mentioned above.

Please reconcile the discrepancy of precinct labelling across all documents and plans to a consistent labelling as they are confusing (eg Precinct A = PRECx1)

IV. Any relevant rules related to and that stems from UFD-Px & DO-Ox3

all rules should be amended to reflect the intensification allowed in the revised walkable catchment areas and revised heights mentioned above.

Any breach in height within the GRZ must be a non-complying activity.

They can help with how you might present your views in a submission, and the steps you'll need to take after lodging your submission. The Friend of Submitter can't provide advice on the merits of the IPI or write your submission for you.

Next steps

Public notification of Plan Change 2 on 18 August starts the formal consultation and decision-making process outlined under Part 6 of Schedule 1 of the Resource Management Act 1991. This process is referred to as the *Intensification Streamlined Planning Process*, and includes the following steps:

Step	Description	
Step 1: public submissions on the plan change	Any person can make a submission to the	
Submissions close 5pm, Thursday 15 September.	Council on the plan change. The process for making a submission is outlined below.	
Step 2: summary of submissions.	The Council prepares a summary of the decisions sought by submitters, and publicly notifies this summary.	
Step 3: further submissions.	People have the opportunity to make further submissions on the decisions sought by submitters in step 1, based on the summary provided in step 2.	
Step 4: hearing by an Independent Hearings Panel (IHP).	An Independent Hearings Panel conducts a hearing on the Plan Change. Submitters who wish to be heard can speak at this hearing.	
Step 5: Independent Hearings Panel makes recommendations.	The Independent Hearings Panel makes recommendations to the Council on the provisions of the Plan Change and the matters raised by submitters.	
Step 6: Council decision on Independent Hearings Panel recommendations.	The Council must decide whether to accept or reject the recommendations made by the	
This step must be completed by 20 August 2023.	Independent Hearings Panel on the Plan Change, and publicly notify its decision.	
Step 7 (if Council <i>accepts</i> IHP recommendations): Plan change becomes operative.	If the Council accepts the recommendations of the Independent Hearings Panel, then the Plan Change (as altered by the recommendations) becomes operative. This means the plan change process is completed.

Environment makes a final decision.	Hearings Panel, the rejected recommendations are sent to the Minister for the Environment, who makes the decision.
