Attachment I – Local Conditions – Kapiti Coast District Council

2.4.1 Maintenance of Above Ground Utility Structures: - add new sub-clause (o)

It is considered that a reasonable time to remove graffiti is within 14 days of notification.

5.2.1 Locating Existing Underground Utilities 1. (a) add new sub-clause

Council requires Utility Operators to apply the following procedure:

- Use a minimum amount of paint when marking out in these areas.
- Use only water based paints.
- If the markings are still visible four weeks after the completion of works, utility operators are to remove markings from Council's infrastructure (particularly footpaths) upon reinstatement/completion of works. This is particular concern within the high pedestrian/cycling areas and retail areas.

5.3.4 Hours of Work – add new sub-clause (c)

Restrictions to Working Hours

Unless the Corridor Manager has agreed that the benefits to the public good outweigh the disadvantages, hours of work shall be restricted as detailed below.

(i) Residential Areas

Construction work shall be restricted to between 8:00 am and 6pm Monday to Friday, 7:30am to 6:00pm on Saturday. Noisy construction work is not permitted at any time on Sundays or public holidays.

Network Hierarchy

Kapiti Coast District Council – Central; Business/Retail & Major & Centre Connector Routes works within the carriageway:

"No works shall take place between 7.30am and 9am, nor 3pm and 6pm Monday to Friday. At other times between 6am and 7pm Monday to Saturday, a minimum of one lane each way shall be maintained." No work shall take place in these areas in the three week period immediately preceding, or within the two (2) week period following Christmas day

To work within the time periods referred to above, the Corridor Manager's written permission is required. As part of the permission, the Contractor is required, in conjunction with the Corridor Manager, to consult affected business owners.

Where work is being undertaken adjacent to, and is likely to impact upon, a residential area, the residential area restrictions shall apply.

(iii) Major, Centre and Local Community Connector Routes – Kapiti Coast District Council Primary Arterial – Kapiti Coast District Council

Conditions are covered in "Attachment II – Specific conditions" below.

Where work is being undertaken adjacent to, and is likely to impact upon, a residential area, the residential area restrictions shall apply.

5.6.4 Specific Requirements for Different Surface Types

Grass seed mixture shall be 85% drought tolerant, amenity turf rye grass and 15% red fescue – other mixtures may only be used on the specific approval of the Council.
