Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your email of **23 December 2024** requesting the following information:

1. For the financial years 2020/21 through to 2024/25 inclusive, please provide an <u>itemised list of all financial payments</u> made to any entity that are not either Elected Councillors/Mayor or KCDC officers (employers), for the following groups and organisations but not limited to, together with the total amount paid and the rationale/purpose for each of the payments made to/budgeted for:

Please refer to the following tables, payments are split by financial year (1 July to 30 June inclusive) and exclude GST. Given the history length of payments requested, sourcing entity names and payment dates would require significant staff time. This part of your request is partially refused under section 17(f) of the LGOIMA as the detailed level of information requested cannot be made available without substantial collation or research.

Consideration has been given to whether your request could be further refined. However, in this particular situation we do not consider this would be possible. I have also considered whether we would be able to respond to this part of your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Council's ability to undertake its day-to-day work would be significantly impacted.

Thank you for your email of **12 February 2025** requesting the following information:

Would you please provide clarity to the following questions:

1. What does "Capacity Funding" actually mean? is it a grant, is it a gift, or something else?

Capacity funding is money provided for a particular purpose. In this case, capacity allowing iwi the ability to engage, stemming from an understanding that our iwi partners do not have resource to support, engage and contribute council business and decision making.

2. Why are these organisations receiving these handouts on who's authority? do any of these have a ToR, Contract, defined services, KPI's, ROI's?

In a 1994 Memorandum of Partnership that established Te Whakaminenga o Kāpiti, the Kāpiti Coast District Council formally acknowledged Te Ātiawa, Ngāti Toa, and Ngāti Raukawa as the tangata whenua, the people of the land.

Council, in some cases, undertakes direct consultation with iwi to carry out its functions and responsibilities. The council is required to consult with Māori on any matter that is likely to impact upon the wellbeing of the tangata whenua.

With the newly formed lwi Partnerships Group, these budget lines form our work programme. Some of these are LTP bids (the majority are historic), that have never been resourced to deliver alongside our iwi partners.

Terms of References, Contracts etc. are in place where required.

3. What is the meaning of "Internal Capability Development"?

In regard to the Māori Internal Capability Development, it is to increase the knowledge capacity of staff and the organisation as this serves to adhere to the Local Government Act of 2002, in particular section 81.

4. What is the meaning of "Build Capacity - IWI"?

That is an old budget line that was utilised for contracting in iwi for advice, such as consents, management plans, or anything that required mana whenua input. We now have a broader range of kaupapa that require capacity from our iwi partners for a Māori community and mana whenua lens. This budget line has now been zeroed out and we now have a more condensed approach that we are still scoping and measuring.

5. Do any of these contributions totalling \$800K under b) have a ToR, Contract, defined services, KPI's ROI's?

Please refer to our response for Question 2.

6. The Urupa grants appears to have two different figures for the same year ended 23/24 & 24/25 (\$15,872 and \$10,260) would you please explain the difference and which if any is correct?

For the year ended 23/24, \$15,872 is actual spend. For 24/25, \$10,260 is also actual spend. However, two quarters remain available to spend. The total budget is \$20k.

7. Table b. line item "Total" - Are you able to provide an explanation as to why FY 22/23 & FY 24/25 Dollar values are vastly lower than FY 21/22 & FY 24/25?

The 21/22 budget included the district plan engagement that Council undertook with iwi.

The 22/23 budget is reflective of limited resource within the team to carry out the work and not a lot of projects (that were kick-started in 23/24) were delivered due to limited resources within the team.

The 23/24 spend includes the iwi partnerships team being recruited.

The 24/25 budget is reflective of the current budget year. The majority of spending within the work programme is towards the end of the financial year.

8. Table b. line item IWI Consultation - would you please explain what the consultation encompassed?

The consultation was for the same purposes for the new Capacity Funding, mainly engagement on the District Plan for 21/22.

9. Table b. line item District Plan IWI - Is there any explanation as to why the FY 21/22 & FY 22/23 costs are exactly the same as for IWI CONSULTATION?

It is the same amount because it is for the same project. Both budget lines were allocated for District Planning engagement. The Iwi Consultation code was the payment to Ngāti Toa. District Plan was the payment to Te Ātiawa.
