

Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your email of **7 December 2023** requesting the following information:

1. End of year Bonuses

Nikau Plant to the value of \$8.50 each. A total of \$2,975.00 (excluding GST) was spent.

b. Total expenditure on presents for staff including, but not limited to 'secret santa' etc Christmas 2022

The Council does not provide presents to all staff at Christmas. At our annual all staff meeting on 25 November 2022, staff were gifted a reusable water bottle to the value of \$6.91 each. A total of \$3,349.50 (excluding GST) was spent. Additional water bottles were purchased for those who could not attend.

3. Christmas Parade

Parade costs including staff, traffic management and fencing, waste management, entertainment, generators, toilets, first aid, marketing/promotion, decorations, buses, volunteer costs, walkie talkies, and venue was \$25,151. We received \$6,100 in sponsorship towards this cost.

There was no Christmas parade in 2022.

4. Christmas Trees and Lights

The lights that were donated by Motor Neuron Disease some 10 years ago have been replaced with new permanent lights on the Norfolk pine tree at the bottom of Maclean Street and some in-ground lights. These lights have an estimated 20-year life and will negate future annual costs associated with putting them up and taking them down plus the need to implement associated traffic management during set up and takedown. The new lights cost \$47,000 plus a one-off install cost of \$6,000.

c. Number of Christmas trees purchased and erected, and the cost of these purchases for 2022.

In 2022 we installed lights on the lamp posts along Marine Gardens at Raumati village and Paraparaumu beach along Maclean Park. 8 sets for each area. \$32,000 plus install of \$6,000. These again stay up permanently and are turned on 1st December each year again saving on installation and removal each year.

All staff Christmas parties are self-funded by attendees. The Council organises an all staff breakfast meeting in November which is a reflection of the year where staff are recognised and collegial awards given for outstanding performance.

In 2022 a Christmas breakfast for the Regulatory team was held. The total cost was \$1,722.60.

9. Office Closure

The Council closes its corporate offices on the three days between Christmas and New Year.

With the exception of the 3 days between Christmas and New Year, all Council staff are required to take annual leave if they are not working over the festive season.

Contractors are not required to work over the Christmas break.
