- 4 An amount of \$5,705 was provided in the 2011/12 budget for the Discretionary Grants Fund.
- 5 An amount of \$31,954 was provided in the 2011/12 budget for the Waikanae Promotion Fund.

- An amount of \$31,954 was provided in the 2011/12 budget for the Waikanae Capital Improvement Grant.
- An amount of approximately \$1.1 million is held in the Waikanae Capital Improvement Fund.

# **CONSIDERATIONS**

#### **Issues**

- 8 Grants are allocated in accordance with the established criteria (attached).
- 9 All applicants have been advised of the criteria and meeting date by letter, phone or email.

## **Applications to the Capital Improvement Grant**

10 The following applications all meet the stated criteria for the Capital Improvement Grant.

# Kapiti Plunket Playgroup

11 Funding of \$4,815.56 is sought to assist with the costs of having a desk built outside the plunket rooms, to create an outdoor play area.

# Kapiti Women's Health Centre Collective Inc.

12 Funding of \$10,000 is sought to assist with the costs of extending and reconfiguring the Kapiti Women's Centre.

# Waikanae Volunteer Fire Brigade

13 Funding of \$28,750 is sought to assist with the costs of purchasing a Fire Police van.

# Menzshed Kapiti Inc.

14 Funding of approximately \$950 is sought to assist with the cost of purchasing a dust extractor and attachments for their shed facility.

#### **Applications to the Discretionary Grants Fund**

# Sands Kapiti

- 15 Funding of \$442.35 is sought to assist with the costs for two people to attend the Sands National Conference in Wanganui, in November 2011.
- 16 This application can be considered under the following Eligibility Criteria:

Community, cultural or sports purposes, including travel both within New Zealand and overseas.

## Ngati Haumia / Ngati Toarangatira

- 17 Funding of \$500.00 is sought to assist with the costs of the 2012 Kapiti Coast Waitangi Day celebrations.
- 18 This application can be considered under the following Eligibility Criteria:

Community, cultural or sports purposes, including travel both within New Zealand and overseas.

## **Applications to the Waikanae Promotion Fund**

#### Coast Access Radio

- 19 Funding of \$7,163 is sought to assist with the costs associated with the purchase and installation of a generator and ancillary equipment. This equipment is required so that Coast Access Radio can meet new Civil Defence legislative requirements.
- 20 This application can be considered under the following Eligibility Criteria:
  - Applications will be considered under exceptional circumstances.

#### Kapanui Primary School

- 21 Funding of \$1,700 is sought to assist with the costs associated with the "Christmas @ Nga Manu" concert.
- 22 This application can be considered under the following Eligibility Criteria:
  - Promotions within the Waikanae ward
  - "Events based" activities

# Kapiti Coast Youth Council

- 23 Funding of \$6,000 is sought to assist with the costs of running the "Youth2U Live" programme of events over the summer of 2011/12.
- 24 This application can be considered under the following Eligibility Criteria:
  - Promotions within the Waikanae ward
  - "Events based" activities

#### Waikanae Pony Club

- 25 Funding of \$1,894 is sought to assist with the costs of providing road calming measures at Pony Club events.
- 26 It should be noted that this application was originally considered at the Waikanae Community Board meeting of 13 September 2011. At that meeting Board members had questions of a financial nature, but there was no-one from the Pony Club in attendance at the meeting.
- 27 The Pony Club were subsequently contacted and invited to supply further financial information, which they have done, and to attend the meeting of 1 November 2011 in order for their application to be re-considered.
- 28 This application can be considered under the following Eligibility Criteria:
  - Promotions within the Waikanae ward
  - "Events based" activities

# **Financial Considerations**

### Waikanae Capital Improvement Fund

29 An amount of approximately \$1.1 million is held in the Waikanae Capital Improvement Fund. The following table shows how that fund has been allocated:
