Council Staff provided the following update about the Placement of a toilet at Ōtaki Estuary:

Agreement has been reached with Regional Council for a toilet to be installed at Ōtaki River Mouth. The final location is being discussed with directly with the Friends of the Ōtaki River. The Friends group will purchase the toilet with funding from the Phillips Foundation and ownership will pass to KCDC on completion. KCDC will manage the facility and share operating costs on a 50/50 basis with Regional Council. Regional Council is to forward a draft Easement document for Council approval once the toilet location is confirmed.

The Board asked that thank you letters be sent to Kapiti Coast District Council, Greater Wellington Regional Council and Max Lutx for all their assistance with this project.

Item 4

The Board discussed the Railway Station building and platform and who maintains and cleans this area. A request had come in from the organisers of the Polar Express in regards to the state of the platform and who maintains this area. Train passengers pass by the railway station and see it untidy and it is not a good reflection of Ōtaki. Council staff will find out who maintains the platform area.
