CONTRACTS UNDER DELEGATED AUTHORITY

PURPOSE OF REPORT

This report provides an update on any contracts over \$250,000 accepted under delegated authority for the period 1 July to 30 September 2016.

CONSIDERATIONS

Issues

<u>Contract 2016/C124 – Paraparaumu and Waikanae Town Centre Project – Kapiti Road Shared Path - Undergrounding Power</u>

- 3 One tender was received.
- It was previously reported to the Corporate Business Committee in August that Electra Limited had been identified as the preferred tenderer. During contract negotiations, further work was identified and included within the final contract awarded to Electra for the sum of \$615,495.
- 5 Electra has estimated that 80% of the contract will be local content via wages, subcontractors and materials where applicable.

2015/C074 - Professional Services for Paekākāriki Seawall

- 6 Five tenders were received, ranging from \$293,659 to \$875,961.
- 7 This tender was openly advertised in GETS and Tender Link and there were no tenders received from Kapiti based contractors.
- The Contract was awarded to Tonkin and Taylor Limited for the sum of \$391,474.
- 9 It is estimated that 80% of the staff allocated to this work is Wellington based, others are Auckland based.

2015/C033 – Waikakariki Stream Upgrades

- 10 One tender was received.
- 11 The Contract was awarded to Fletcher Construction Company Limited trading as Brian Perry Civil for the sum of \$366,657.
- Brian Perry Civil is engaged by Council for the Town Centre design and build project after following a competitive tender process.
- 13 It is estimated that 50% of materials and resources will be from local suppliers.

Financial Considerations

14 There are no financial, legal, consultation and publicity considerations.

SIGNIFICANCE OF DECISION

15 The Council's significance policy is not triggered.
