## Bride Coe

Ms Coe thought the community consultation meeting was an excellent idea. She raised concern over the stormwater outlet. She also raised her concerns regarding Flyby Wire. These concerns include aviation fuel, fuel pollution, noise, and public access to the facility. Ms Tod advised that the Flyby Wire applicant is relying on an existing resource consent so Council does not have the same ability to ask for information. If noise becomes an issue and there are complaints made, the noise would then be monitored by Council. The tracks have been looked at by Council and issues are being followed up on. Ms Coe asked that the community be kept informed about what is happing with Flyby Wire and the Community Board monitor the situation.

On behalf of Graham Coe who was not present at the meeting, she raised concerns about the new 30-minute parking times outside the St Peter's Hall. The Chair advised that an update to the Community Board by Gary Adams on this issue will be discussed later in the meeting under Matters Under Action.

A meeting with all stakeholders to discuss Perkins land was held at the Council on Tuesday, 4 December 2018. This land will be a major item for Council during the last part of this triennium. There was good representation and the meeting went well.

#### (e) <u>Community Board Members' Activities:</u>

Cr Holborow and the Mayor went on Andy McKay's "start of the season" Penguin Walk. The penguins seem to be up on numbers compared with last year and that is good news.

Ms Ewans attended the 25 November 2018 community meeting and compiled all the seawall feedback which was for something simple, rustic and fit for purpose and not overly decorative. She attended the Perkins' surplus land meeting at Council and has been appointed editor of the website Paekākāriki.nz.

Cr Holborow suggested "Perkins surplus land" be referred to as "Transmission Gully surplus land".

In response to a question regarding the status of the Transmission Gully surplus land, the Chair advised there will be a subsequent community discussion on a "process" for a way forward on 29 January 2019.

**Item 2:** Gary Adams is doing further work on this. There is not enough room next to the reserve to create an angle parked car parking area. There is not sufficient width for a vehicle to park without blocking the gate into the reserve. The existing hockey stick line marking has been reviewed and will be remarked during the annual summer refresh. He will be undertaking parking surveys over December and January to look at numbers of vehicles and duration of stay at the south end of Ames Street and report back to the Board on 12 February 2019. He did some observations last Saturday and there seems to be a significant reduction in people parking there which is encouraging.

**Item 3:** Parking time limits – Mr Adams will be bringing a parking report to the 12 February 2019 meeting looking at increasing the time restriction from 30 minutes to two hours in the parking bay outside the St Peter's Hall. He is seeking approval from the Board that no further consultation is necessary. The Board felt that it was the community's understanding that there should be a longer parking time and no further consultation was necessary. Mr Adams also requested direction from the Board regarding the two P10s outside the Dairy. The Board felt there was strong support for these two P10s. Mr Adams has also asked for the production of some long-stay parking signs to direct traffic to the parking area on Robertsons Road.

The Board asked that Seawall Art be added as an item under Matters Under Action.
