Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your email of **28 March 2024** requesting the following information:

This is a request for official information relating to funds paid to Taituarā – formally known as the NZ Society of Local Government Managers (SOLGM).

Please provide for the 2023 calendar year:

1. A list of all payments from the Council group (i.e. including any CCOs) to Taituarā

b. whether it was recovered (or deducted from the pay) from the relevant employee enjoying the membership or services related to the same.

The Council considers that the membership and any corresponding training courses attended by employees as part of their professional development and therefore a beneficial investment by the Council. Consequently, the Council would not seek to recover these costs from employees.

Please note that any information provided in response to your request may be published on the Council website, with your personal details removed.

3. Given the nature of Taituarā as a membership organisation – in effect the employment union for local government managers – if membership dues are not recovered or deducted, please provide:

Taituarā is not a union and play no role in the negotiation of employment contracts or employment relations for any individual or group within the sector. Membership is voluntary rather than a requirement as is the case for example with lawyers, accountants etc.

a. the reasoning (if any) for not deducting the amounts (i.e. Why should ratepayers pay for a private organisation/benefit?) and

This has been answered in question 2(b) above.

b. whether the Council does this for any other employment union or professional/networking association. If so, which ones?

The Council has a number of employees who are members to professional bodies. This includes, but is not exhausted to, Lawyers, Accountants and other internationally accredited organisations. The Council considers the necessary expertise of these professions integral to the operation, compliance and delivery of services to meet the community obligations the Council has been mandated to perform. Consequently, the Council would not seek recovery of these professional memberships.

4. If the Council considers that the membership for Council officers is as part of their role at the Council (and therefore not for private benefit) please provide this information and explain how Taituarā is not therefore treated as a CCO under s 6(1) of the Local Government Act 2002 for the purposes of the Council group's statutory reporting.

Taituarā does not meet the legal definition of a CCO as specified under section 6(1) of the *Local Government Act 2002*. Council considers that a Council officer's Taituarā membership is as part of their role at the Council

It is the individual not the council that is a member of Taituarā. No local authority or group of local authorities own or control 50 percent or more of the voting rights at any meeting of Taituarā, nor does any local authority or group of local authorities have the right to appoint 50 percent or more of the members of our governing body.
