UPDATE: GROUP MANAGER PEOPLE & PARTNERSHIPS

Janice McDougall provided the following update:

<u>The Maramataka</u> – Council staff have been working closely with Te Atiawa. The theme this year is the ART confederation.

The Maramataka will be launched at the end of July with images of past Maramataka covers. The month of May will be dedicated to Te Pehi Parata.

Whakarongatai have requested to host the launch of the Maramataka.

<u>Housing</u> – Participation in a regionwide initiative that falls out of the Wellington Regional Investment Plan, looking at where growth is expected and how to best manage the impacts of that and seize the opportunities that presents.

The regional team coordinating the work are keen to engage with iwi around what role iwi would like in the project going forward. Members requested that Kim Kelly attend a future meeting of Te Whakaminenga o Kāpiti.

Clinton Fisher who is carrying out an assessment of housing needs would contact each iwi.

TPK was organising a Papakainga Housing Forum in Ōtaki on 20 and 21 July at Raukawa Marae. The Chair invited a staff contingent to attend and listen.

Council Meeting Agenda 27 June 2019

Rupene raised that iwi would wish to be involved the process for any organisational review process.

Chris Gerretzen raised that Te Ātiawa ki Whakarongotai Charitable Trust support Cr Cootes request for an independent review of Council. The Chair later requested that iwi support for the request for an independent review be noted.

Members were invited to discuss with Cr Cootes about how to be involved.

Te Whakaminenga o Kāpiti 19/06/287

PRESENTATION: ECONOMIC DEVELOPMENT STRATEGY REFRESH & THE KĀPITI DESTINATION STORY

Leanna Covacich spoke to a presentation. Ms Covacich highlighted the cruciality of partnerhsip and sought guidance on how best to engage going forward around both the Kāpiti Economic Development Strategy Refresh and on the Kāpiti Desination story.

Ms Covacich sought feedback regarding where the four pillars within the draft refreshed strategy resonate and are relevant. She highlighted that pathways for our rangitahi are crutial.

Ms Covocich sought the Committee's view on whether it wanted to see the current Maori Economonic Development Strategy refreshed or whether Māori Economic development should be included in the overall economic development strategy with a specific implementation plan.

Members requested that the current strategy be recirculated. Ms Covacich was requested to send prospective workshop dates in order for a workshop to take place before the next meeting of Te Whakaminenga o Kāpiti.

Kirsten Hapeta left the meeting at 11.24am and returned at 11.26am.

It was confirmed that an attendance payment would be available for those involved in the workshop.

Ms Covacich then spoke to a presentation on the Kapiti Destination story.

Members discussed the importance of the use of history as a key element of the campain. Members discussed the need to reflect the Māori world view.

Concern was raised about the potential to further increase in the price of housing. While business growth for locals is important, consideration would need to be given to the necessary infrastructure, the waste issues and the challenges as well as benefits of attracting business.

It was raised that a large element of the Kāpiti Destination Story relates to tourism and on the Coast work around tourism, especially around sites of significance, should be led by Maōri. There was discussion about the use of the phrase 'wake-up' in the 'Wake Up to Kāpiti' campaign slogan, as the phrase can be used in a derogative way referring to somebody who is lazy.
