Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your email of **9 August 2023** requesting the following information:

1. I thought the question asked of the Chair to provide the costs for CAP to be relevant however, the time and place may not have been correct. Is the something that a Chairperson should be aware of?

No, ordinarily this is not something that a Chairperson of a panel would be aware of. The Takutai Kāpiti Chair is independent to Council and is not directly part of the operational elements of the project. The Chair does not manage the budget, instead this is managed internally by Council staff.

2. Are you able to provide me with the following?

• The CAP Expenses so far to date,

The expected remaining expenses for the completion of the CAP process,

The question regarding '*CAP expenses so far to date*' has been interpreted as all the costs for the Takutai Kāpiti project to date, including (but not limited to) payment to Coastal Advisory Panel members. Therefore, overall direct costs for the project (excluding overhead costs) have been included, along with a breakdown that it is specific to payments made to the Coastal Advisory Panel.

From August 2021 until to date, at total of \$40,817.09 has been paid to CAP members. This includes attendance to CAP meetings, community engagements, independent CAP meetings and travel mileage.

Please note that any information provided in response to your request may be published on the Council website, with your personal details removed.

As at the end of July 2023, overall costs amount to \$2,736,639 excl GST.

The forecasted direct costs for Takutai Kāpiti for 1 July 2023 – 30 June 2024 are \$1,572,000 excl GST (excluding overhead costs). Takutai Kāpiti is currently expected to be completed by 30 June 2024.
