Making a further submission on Proposed Plan Change 2

Please note the original submission that you made during the submission period (18 August to 27 September 2022) is still valid. A 'further submission' is a submission that supports or opposes a submission on a proposed plan change. You do not have to make a further submission, but it is your opportunity to have your say on the changes sought by others, if you wish to.

Further submissions close at 5pm, Thursday 24 November 2022.

You can make a further submission:

- at Have Your Say
- by completing Further Submission in support of, or opposition to, submission on notified proposed plan change (Form 6) and emailing it to district.planning@kapiticoast.govt.nz; or
- completing a hard copy of the Further Submission form (adding extra pages as needed) and posting it to: Kāpiti Coast District Council 175 Rimu Road Paraparaumu 5032.

You must send your further submission to the relevant original submitter within 5 working days of lodging your further submission with Council. We've included a list of submitters, along with their address for service (commonly an email address), in the Summary of Decisions Requested report.

Further submissions must be limited to the matters raised by others in their submissions on PC2. You can't use a further submission to raise new points about the Plan Change.

Who can make a further submission?

To make a further submission, you must either be a person that represents a relevant aspect of the public interest, or you must have an interest in PC2 that is greater than the general public (as outlined in <u>clause 8</u>, Schedule 1 of the RMA).

Here are some examples of where you might have an interest that is greater than the general public:

- if a submission relates to a proposed rezoning, and your property is located in or next to the proposed rezoning;
- if a submission relates to a proposed new precinct, and your property is located in or next to the area affected by the change;
- if a submission relates to a change to a proposed rule or standard that applies to your property.

Hannah can help with how you might present your views in a further submission, and the steps you'll need to take after lodging your further submission, including sending it to the relevant original submitter(s) within 5 working days of lodging it with the Council. The Friend of Submitter can't provide advice on the merits of the plan change or write your submission for you.

We now invite further submissions on Proposed Plan Change 2 to the Operative Kapiti Coast District Plan.

About Proposed Plan Change 2 (PC2)

PC2 is the Kāpiti Coast District Council's Intensification Planning Instrument, which is required by the Resource Management Act 1991 (RMA). This plan change incorporates the Medium Density Residential Standards into the District Plan, gives effect to Policies 3 and 4 of the National Policy Statement on Urban Development 2020, rezones some areas as General Residential Zone, provides for tangata whenua to develop papakāinga on ancestral land, and makes several other supporting or consequential amendments.

More than 200 submissions were received during the submission period 18 August - 27 September 2022. They seek a wide range of changes to the proposals.

A further submission can only express support or opposition to a matter raised in an original submission. It must not raise new points.

A further submission must follow the prescribed form: Form 6 of the Resource Management (Forms, Fees, and Procedure) Regulations 2003.

A copy of the further submission must also be sent to the original submitter within five working days of providing it to Council.
